4-22-98 PT BOP & csg to 600 psi/30 min, OK. Drilling ahead.

4-23-98 Drill to TD @ 2270'. Circ hole clean. TOOH. TIH w/72 jts 3 1/2" 9.3# J-55 csg, set @ 2261'. Cmt w/335 sx Class "G" 65/35 poz w/2% calcium chloride, 6% gel, 0.25 pps Cellophane, 5 pps Kolite (626 cu.ft.). Tailed w/100 sx Class "G" neat cmt w/2% calcium chloride, 0.25 pps Cellophane (116 cu.ft.). Circ 15 bbl cmt to surface. WOC. PT csg to 3800 psi/15 min, OK. ND BOP. NU WH. RD. Rig released.
