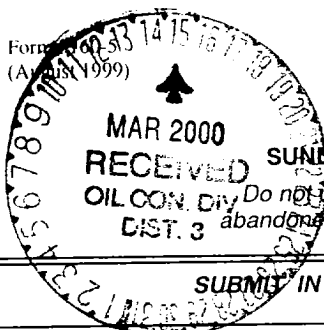

Cmt'd csg w/75sx Type III cmt w/1/4#/sx celloflake and 2% CaCl₂ (14.6 ppg, 1.39 cuft/sx). Disp cmt w/7.5 BFW. PD @ 11:30 pm, 1/28/2000. Bumped plug to 500 psig (275 psig over final disp press). Circ 21sx cmt to surf. WOC for weekend. Drld out cmt w/6-1/4" bit and drld ahead to 2284'. TD. RU and ran 4-1/2", 10.5#, J-55, STC csg and set @ 2284'. RU BJ Services and cmt'd csg w/285 sx of Type III cmt containing 1/4 pps celloflake, 10 pps CSE (compressive strength enhancers), 3% KCl, 6% gel (mixed @ 12.5 ppg, 2.07 cuft/sx). Total slurry vol 590 cuft. Displ cmt w/35.8 BFW. PD @ 8:15 am, 2/4/2000. Bumped plug to 1500 psig (1255 psig over final disp press). Circ 27sx of cmt to surface. ND BOP, set slips w/full csg wt. Rig released @ 10:30 am (MST), 2/4/2000. WO completion.
