Cross Timbers Operating Co. reached a total depth of 2,006' KB on 10/15/00. The drilling rig was unable to pull the drill pipe off bottom and got stuck. A Pulling unit was moved in to rec the drill pipe and set the production casing. On 10/16/00 a pulling unit moved over the hole and on 10/24/00 the drill pipe was recovered.

On 10/24/00, Cross Timbers set 53 jts of 4-1/2", 10.5#, J-55 casing @ 2.168' KB. The production casing was cemented with 250 sx of cement of 65/35/6 mixed @ 12.4 ppg & 1.92 cuft/sx. 20 bbls (112 cuft) of good cement was circulated back to surface. Cross Timbers released the pulling unit.
