Will drill 6-3/4" hole to 4000' and run 4000' of 4-1/2" 11.6#/ft J-55 casing and cement with 252 ft³ 50/50 pozmix with 2% gel and 10% salt. Circulating medium will be clear water, natural mud and water loss control additives. No abnormal pressures or temperatures are anticipated. Will run Induction and Density Logs. Blowout preventer schematic is attached. The gas from this formation is not dedicated to a gas contract.

INSTRUCTIONS

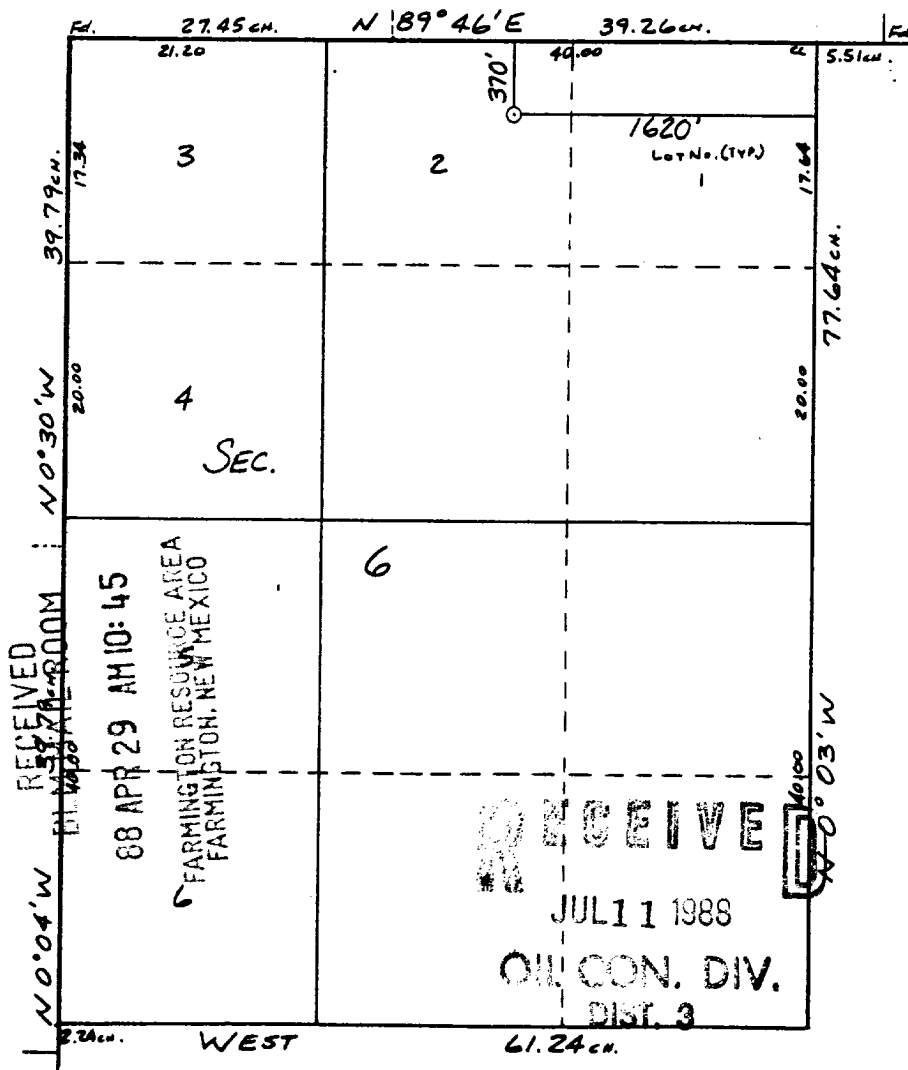
