It is proposed to drill this well with rotary tools to a depth sufficient to test the Granger-Dakota formation. Estimated top Granger-Dakota 6,100', and estimated total depth 6100'.

8-5/8"OD casing will be set at approximately 350' and cemented with sufficient cement to cement from bottom of casing to surface, est 300 sz. If well is productive, 4-1/2"OD casing will be set at total depth and cemented with sufficient cement to protect all zones, estimated 1500 sz in two stages. Productive zones will be perforated, tested, treated if necessary, and well completed to Granger-Dakota formation.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, as indicated, on all types of lands and leases for appropriate action by either a Federal or a State agency, or both, pursuant to applicable Federal and/or State laws and regulations. Item 1: If the proposal is to redrill to the same reservoir at a different subsurface location or to a new reservoir, use this form with appropriate notations. Consult applicable State or Federal regulations concerning subsequent work proposals or reports on the well.
