D/O cmt & retrieve RBP. D/O CIBP @ 1376' Run 3-1/2" csg to 1429' with formation pkr collar set @ 1300'. Cmt 3-1/2" x 5-1/2" annulus to surface. Proceed with original re-stimulation plans.
