Had packer set at 1200' (perfs at 1256'-1264') made one run swab tbg. Dry check for gas none, made swab run no fluid TOH w/pkg. TIH open ended to cement.

Spot cement plug across perfs from (1256'- 1264') spot cement plug from 1314'-1114' 32 sxs CI-B cement.

Spot cement plug from 435'-103' 64 sxs CI-B cement pull up to 120' and reverse hole-clean. LD tbg. run HCS and sqz csg leat at 103' w/ 30 sxs CI-B cement inside and 23 sxs outside csg from 103' to surface. Cut off wellhead and install dryhole marker
