This well was to be recompleted to the Basin Fruitland Coal, however was not due to casing damage. The GCU 42 has approximately 16' of net Fruitland Coal potential pay from 1306' - 1322'.

BHP proposes to set a 7" cast iron bridge plug at 1339' RKB (bottom of 7" Csg), isolate and cement squeeze the damaged portion of casing, clean out cement, pressure test for Csg integrity, and temporary P & A the well; to be recompleted in the future to the Fruitland Coal.
