Propose to rig up work over unit, pull tubing, rerun tubing with packer set packer (top Dakota perforations at 6266') at 6230', swab well off test all three zones (6266-76, 6284-90, & 6346-70) together, pressure up on back side and see if Gallup perforations are O.K. if well makes to much water to produce as reported, pull packer, rerun packer with retrievable bridge plug, Isolate each zone and test, when water is located, squeeze off perforations and retest, repeat if necessary, if production zone is shut off, re-perforate top of zone, re-acidize and re-frac.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
