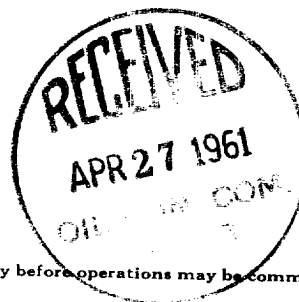

DETAILS OF WORK

Spudded 12-1/4" hole on April 14, 1961, and drilled to 206'. Set 8-5/8" casing at 204' with 135 sacks cement containing 2 percent Calcium Chloride. Circulated 15 sacks of cement. After waiting on cement, tested 8-5/8" casing with 750 psi for 15 minutes, which held with no indication of pressure drop. Reduced hole to 7-7/8" at 206' and resumed drilling operations.
