As per our original sundry notices, a bridge plug topped with cement was placed above the Dakota in the subject well to properly abandon the Dakota interval. During the recompletion, a second bridge plug was set below the Fruitland zone to isolate the lower segment of casing from the pressures encountered during fracture stimulation of the Fruitland. This bridge plug is intended to be temporary and will be drilled out upon depletion of the Fruitland in order to properly place cement plugs across the Gallup and Mesaverde zones for the ultimate abandonment of the well. We therefore, request permission to leave both the Gallup and Mesaverde zones in a temporary abandonment status until final abandonment of the wellbore.
