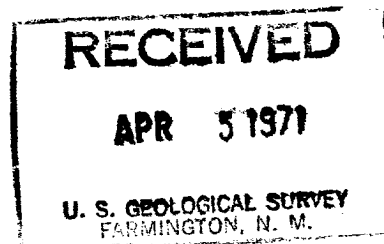

Moved in service unit and set tubing choke at 5983'. Hooked up blowout preventer and blew well down. Pull tubing, ran gauge ring and set Model "P" bridge plug at 6170'. Ran tubing and wireline tool and recovered tubing choke at 6027'. Blew well thru tubing with open 2" to clean up. Put well back on line 2-17-71. Well tentatively finished 2-24-71 gauging 214 MCFD with TFF 380 and CP 560. Before work flow rate was 0 MCFD.
