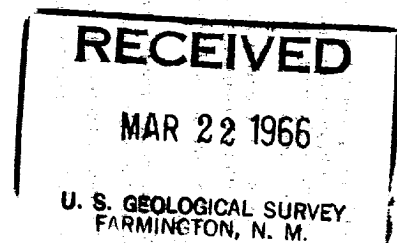

Instructions

Item 1: If the proposal is to redrill to the same reservoir at a different subsurface location or to a new reservoir, use this form with appropriate notations. Consult applicable State or Federal regulations concerning subsequent work proposals or reports on the well.

Item 4: If there are no applicable State requirements, list them on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

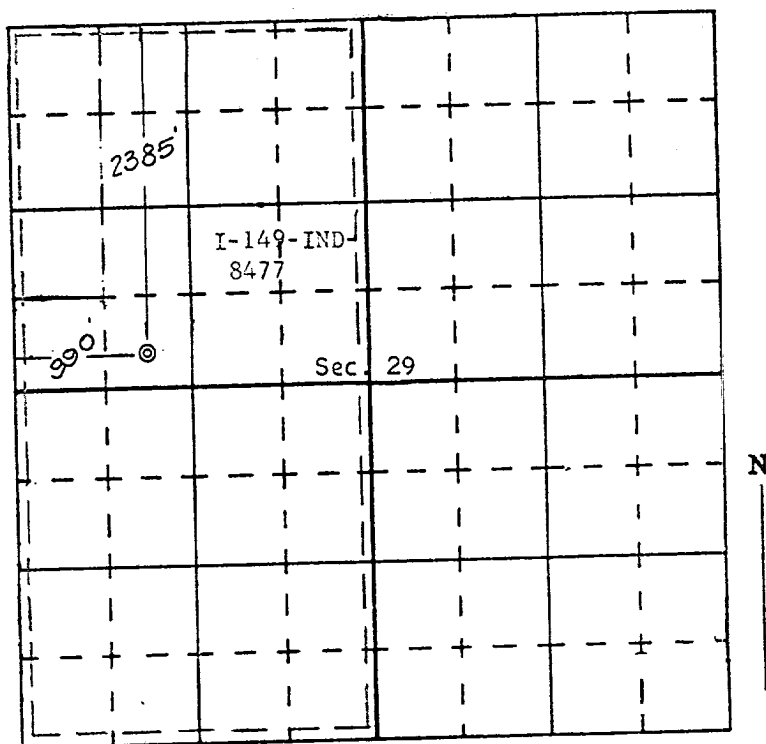
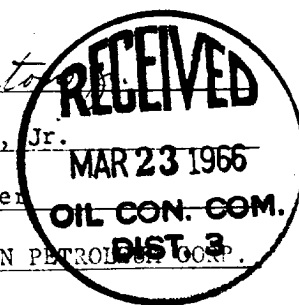
