MIRUSU 11/21/97. TIH with tbg and CIBP, set CIBP at 5500'. Load and test CIBP and casing for 15 minutes to 500#. Held okay.

Spot a cmt plug on top of CIBP with 38 sxs Class B cmt. Spot a cmt plug with 17 sxs Class B cmt from 2900'-3100'.

Perforated at 375', 275', 220' with 2 jspf, .340 inch diameter, total 6 shots fired, to try to circ cmt to surface. Failed at 275'. Spot a cmt plug with 38 sxs Class B cmt from 1050'-1535'.

TIH to 430' Spot 25 sxs Class B cmt over perfs at 375' and 275' that would not circulate. Circ to surface. Cut off well head and top of casing strings at surface. Install P&A marker.
