Energy Reserves Group, Inc. proposes to change casing plans for the above referenced well. Drill 12 1/4" hole to 120'-200' maximum. Set 8 5/8", 24# casing to that depth. Drill 6 3/4" hole to T.D. and set 4 1/2", 9.5 casing. Cement to surface if the Ojo Alamo Formation has not been cemented off by the surface casing. BOP will consist of an 8", series 900, 3000# dual ram preventor.
