The subject well was spud @ 3:30 PM on 1/22/90. Drilled 12 1/4" hole to 145' KB. Ran 3 joints 8 5/8" 24# J-55 casing to 144' KB. Cemented with 105 sx (121 ft³) Class "G" with 1/4#/sx Flocele and 3% CaCl₂. Good circulation throughout and circulated 7 bbls of cement to surface. WOC 12 hrs. NU BOP. TIH with 7 7/8" bit. Pressure test BOP and casing to 1000 psi. Held OK. Drilled to 1513'. Cored Basal Fruitland Coal from 1513' to 1524'. Drilled to 1761'. Ran DIL, FDC/CNL and Microlog. Ran 42 joints 4 1/2" 10.5# J-55 to 1750'. Cement with 300 sx (384 ft³) 50-50 Pozmix w/2% gel, 1/4#/sx Flocele, and 10% salt followed by 130 sx (150 ft³) Class "G" with 0.5% D59, 0.4% D65, 0.2% D136 and 0.25% D79. Good circulation throughout and circulated 17 bbls cement to the surface. Released rig 1/27/90.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
