- 2. Check and record tubing, casing and bradenhead pressures.
- 3. Blcw down wellhead, kill if necessary.
- 4. Nipple down wellhead, nipple up and pressure test BOP.
- 5. TOH with tubing.
- 6. Log Fruitland Coal interval with CBL/GR/CCL to insure zonal isolation across FC.
- 7. Se: RBP at 1545.
- 8. Perforate the following interval with 4JSPF, 120 deg. phasing: FRLD 1531-1542. Basal stringer at 1544-1547 on top of PC sand will <u>not</u> be perforated to ensure effective frac in FRLD. Also interval from 1380-1392 has high ash content and will <u>not</u> be perforated.
