Ran 41 joints of 4 1/2", 10.5 ppf, K-55, ST&C casing with cement nose guide shoe, float collar one joint off bottom. bowspring centralizers at 1744', 1684' 1597', 1511', 1425', 1259' & 1098', and turbolizers at 536', 492', 448', 404', & 361'. 1751.17' of casing set at 1765' KB. Float collar at 1722'KB. Cemented with 195 sacks (245.7cf) of 50-50 class G Poz with 2% gel, 10% salt, and 1/4# celloflake per sack followed by 100 sacks (116.0 cf) class G with 1/4# celloflake per sack. Circulated 8 bbls. cement to surface. Job complete at 7:00 PM, 11/05/94.

This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
