Casing set at 219' KB. Cement with 65 sacks (76.7 cf) Class B with 2% CaCl2 and 1/4# celloflake/sack. Circulate 4 bbls. cement to surface. Job complete at 8:00 PM, 04/20/95. *Casing Test 600# 15 min*

04/23/95: Drill 6 1/4" hole to TD of 1859'. Ran 1846.77' of 4 1/2", 10.5 ppf, J-55 casing with cement nose guide shoe, float collar one joint above bottom, 4 1/2 x 6 1/4" centralizers/turbolizers at 1836', 1772', 1686', 1600', 1429', 1257', 700', 657', 615', 568' and 525'. Casing set at 1858' KB. Float collar at 1815' KB. Cement with 260 sacks (327.6 cf) 50/50 Class G Poz with 2% gel, 10% salt and 1/4# celloflake/sack. Tailed in with 50 sacks (57.5 cf) Class G with 1/4# celloflake/sack. Circulate 9 bbls. good slurry to surface. Job complet at 9:15 PM, 04/23/95. *2500 pressure Test 30 mins, 5/5/95*
