Perforated lower Fruitland Coal 1,722'-37' with 4 JSPF. Broke down perforations with 500 gals 15% HCL acid. Fraced lower Fruitland Coal with 20,862 gals x-linked 20# gelled 2% KCl water and 4,500 lbs 20/40 sand. Screened out.

Re-fraced lower Fruitland Coal with 4,773 gals 2% KCl water, 5,504 gals 20# linear gelled 2% KCl water, 44,940 gals x-linked 20# gelled 2% KCl water, 2,507 lbs 40/70 sand and 46,508 lbs 20/40 sand.

Set CIBP @ 1,700'. Perforated upper Fruitland Coal 1,564'-68', 1,572'-78', 1,595'-98', 1,601'-04' and 1,644'-46' @ 4 JSPF.

Fraced upper Fruitland Coal with 2,310 gals 2% KCl water, 48,261 gals x-linked 20# gelled 2% KCl water, 1,711 lbs 40/70 sand and 53,320 lbs 20/40 sand.

Drilled out CIBP @ 1,700'. Landed 2-3/8" tubing @ 1,729'.
