Spudded May 28th, 1958. Set 183.46' of 10-3/4", 32.75#, H-40 casing @ 196.46', cemented w/200 sx Portland regular w/2% CaCl. Volume of cement slurry 244 cu. ft. Approximate temp. of cement slurry when mixed 60° F. Estimated formation temp. 70° F. Estimated strength of cement 2575# per square inch. Cement was in place 12hrs before test. Casing tested OK.

Set 3662.40' of 7-5/8", 26.40#, J-55 casing @ 3675', cemented w/150 sx Portland regular w/8% gel plus 1/4# floccs per sx and 50 sx neat w/2% CaCl. Cement was in place 24hrs before test. Casing tested OK.

Set 1955.54' of 1 1/4", J-55 and 248.00' of 15.50#, J-55 liner @ 5834', liner hanger @ 3626.96', cemented w/200 sx Portland regular w/4% gel plus 1/4# floccs per sx. Cement was in place 18hrs before test. Pressured to 2000#, held OK.
