7" at 3450' w/155 sacks cement to cover Ojo Alamo.

4 1/2" at 5596' w/220 sks. cement to cover top of line.

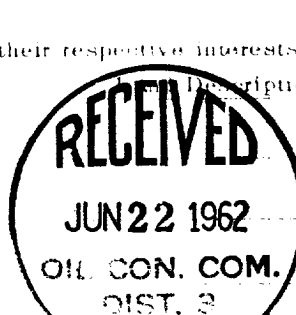

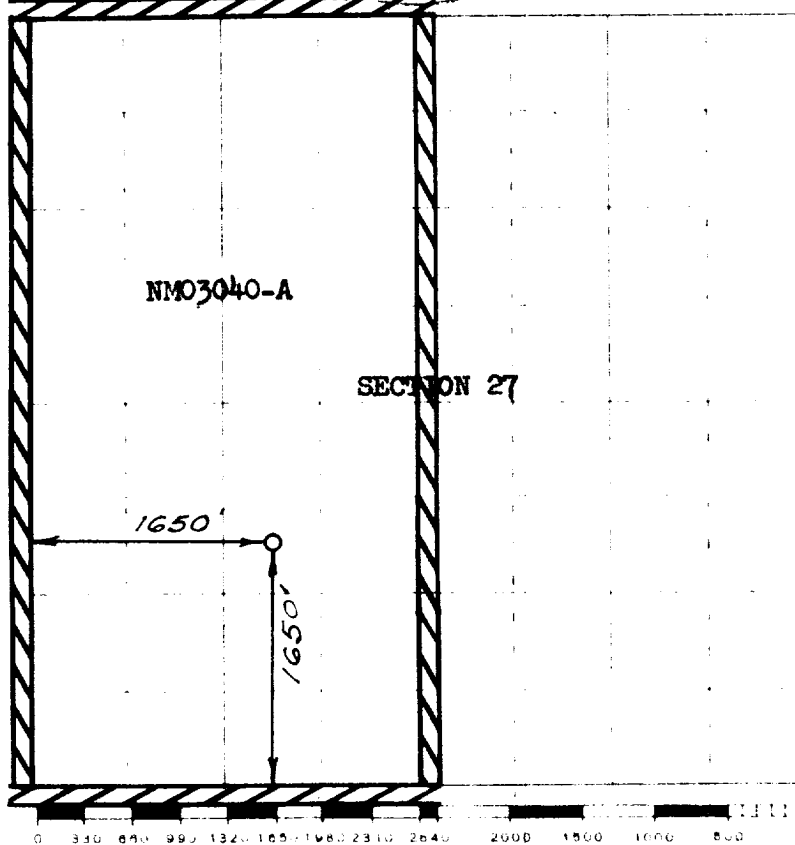
