In 4/98 fish was left in the hole on this well and we put the well in a temporary abandoned status. Our service company now feels that they have improved their fishing capabilities substantially. We are going to attempt again to retrieve the remaining fish in the hole and return this well to production. Work is schedule to begin in mid-September. Expect the subsequent report returning this well to production sometime after September. If our attempts fail, we will submit different plans.
