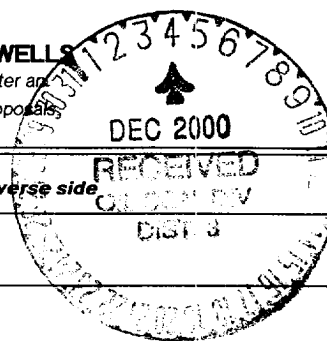

RIH w/8-3/4" bit & tagged cement @ 320'. PT casing to 200 psi then 1500 psi. Good test. Drilled cement to 350'. Drilled formation ahead to 3775'. Circ. hole. RIH w/7", 20#, J-55 casing and landed @ 3775'. RU BJ to cement. Pumped 20 bbls preflush and 20 bbls mud clean ahead of 10 bbls dye water. Then pumped Lead - 500 sx (1190 cf - 212 bbl slurry) Type 3, 35:65 POZ w/5#/sx Gilsonite, 0.25#/sx Cello-flake, 3% KCL, 6% Bentonite, 10#/sx CSE, 0.4% FL-25, 0.02#/sx Static Free. Pumped tail - 50 sx (70 cf - 12.46 bbl slurry) Type 3, 1% CaCl2, 0.25#/sx Cello-flake. Displaced w/151 bbls H2O. Plug down @ 0630 hrs 11/11/00. Circ. 8 bbls cement to surface. ND BOP, set slips and cut off casing. NU BOP, manifold and lines. PT - OK. RIH w/bit & tagged up @ 3730'. PT rams, and casing to 200 psi and then 1500 psi. Good test.
