Phillips will DHC the Mesaverde and Dakota interval of the subject well per Order 11363. Production will be reported using the subtraction method for 12 months and then convert to the ratio method for the life of the well. The Dakota Production forecast for the next 12 months is as follows:

Partner notification was made with the original Ref. Case R-10770. Mesaverde perforations are between 4446'-5916' & Dakota perforations are between 7985'-8080'. Pore Pressure for MV is 750 psi & 2347 psi for the Dakota. The pore pressure of each zone is lower than 0.65 psi/ft for all zones(Rule 303.C.1.c). The value of production will not be decreased by commingling. A copy of this will be sent to the BLM.
