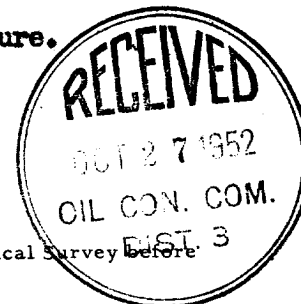

DETAILS OF WORK

Well was spudded October 13, 1952. 9 5/8" cmt. at 234' with 125 sacks. Tested for 30 minutes with 500# pressure; no leaks. Cement plug was drilled October 14, 1952, tested with 500# pressure for 30 minutes, with no drop in pressure.
