MIRU Big A #18. Closed sliding sleeve and set plug in "F" nipple. ND WH. Installed BPV & NU BOPs. Unseat packer and COOH w/packer and sliding sleeve. RIH w/2-3/8" tubing and landed @ 5997' with "F" nipple @ 5964'. ND BOPs and NU WH. PT tubing. Pump off check. RD & MO. Turned well over to production department.
