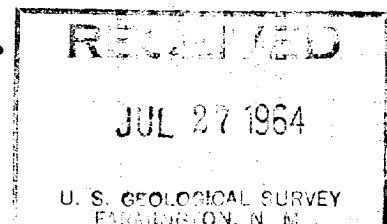
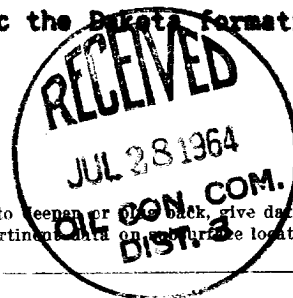

Propose to cement production casing in 3 stages. 1st stage w/150 ex reg + 2% gel, 2nd stage - set DV tool below Point Lookout formation & cement to protect the Mesaverde formation w/approx. 300 cu. ft. 50/ 50 pozmix & Class C cement, 3rd stage - set DV tool below Pictured Cliffs formation and cement w/approx. 350 cu. ft. 50/50 pozmix & Class C cement.

Will perforate and sand water frac the Dakota formation.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, as indicated, on all types of lands and leases for appropriate action by either a Federal or a State agency, or both, pursuant to applicable Federal and/or State laws and regulations. Item 1: If the proposal is to redrill to the same reservoir at a different subsurface location or to a new reservoir, use this form with appropriate notations. Consult applicable State or Federal regulations concerning subsequent work proposals or reports on the well.

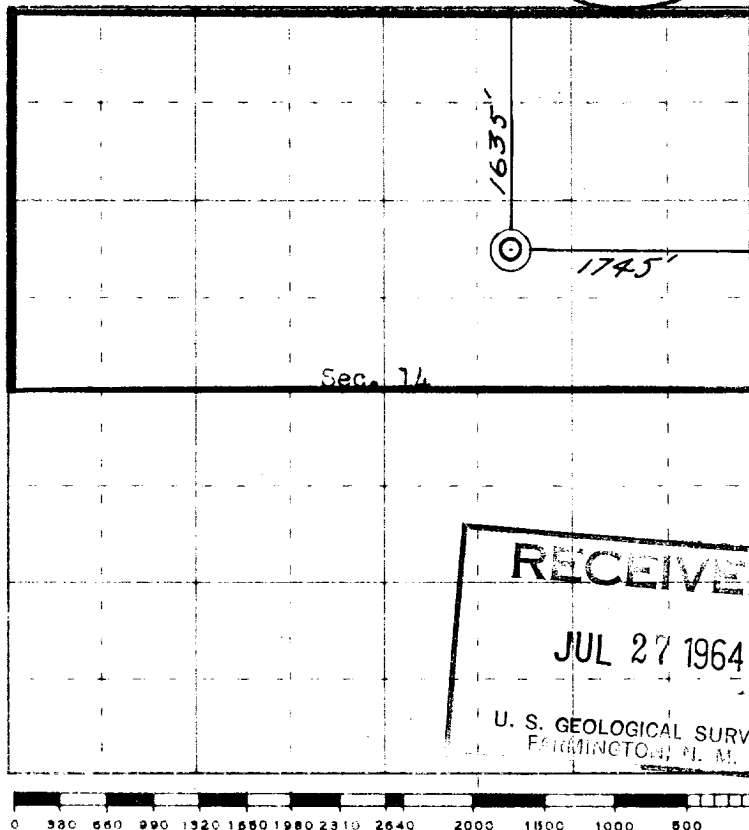
