Drilled out CIBP then cleaned out to CIBP @ 7875'. Drilled out CIBP @ 7875'. Circ. hole clean to PBTD @ 8107'. COOH. RIH w/2-3/8". 4.7# tubing and set tubing @ 8047' with "F" nipple set @ 8015'. ND BOP & NU WH. Pumped off expendable check. RD & released rig 1/2/01. Production from the MV and DK intervals was commingled on 1/9/01.
