### DETAILS OF WORK

It is intended to mud drill a well with rotary tools thru the Mesa Verde formation. Mud circulation will be used thru the Pictured Cliffs and set intermediate casing. Gas circulation will be used thru the Mesa Verde and production liner will be set. Possible productive intervals will be perforated & fractured. Est. T. D. 5987'.

#### Casing Program:

- 9 5/8" @ 120' w/100 sks. cement circulated to surface.
- 7" @ 3909' w/150 sks. cement to cover Ojo Alamo.
- 4 1/2" @ 5987' w/175 sks. cement to cover top of liner.

The E/2 of Section 17 is dedicated to this well.

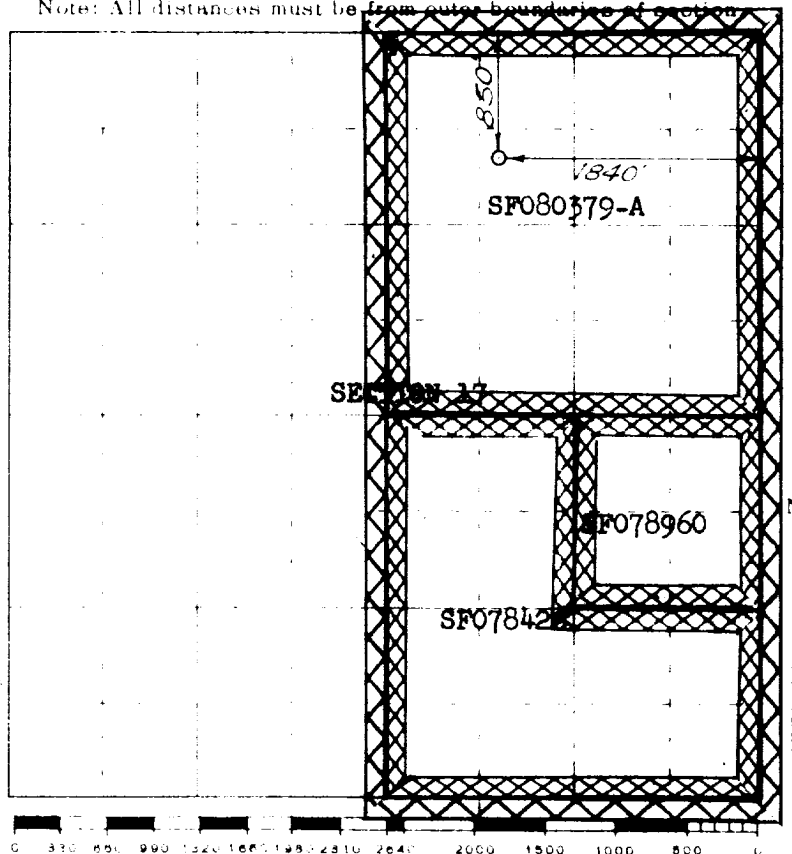
