

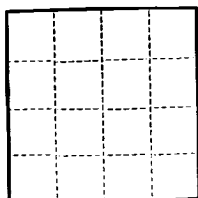

DETAILS OF WORK

It is intended to drill & finally complete a well in the Dakota formation & Mesa Verde formation. Mud circulation will be used thru the Pictured Cliffs & set intermediate casing. Possible productive intervals will be performed & fractured. Est. T. D. 8050'.

- 12 3/4" at 300' w/350 sks. cement circulated to surface.
- 8 5/8" at 3710' w/200 sks. cement circulated to surface.
- 7" at 7650' w/200 sks. cement.
- 5" at 8050' w/100 sks. cement.

The W/2 of Section 30 is dedicated to the Dakota formation.

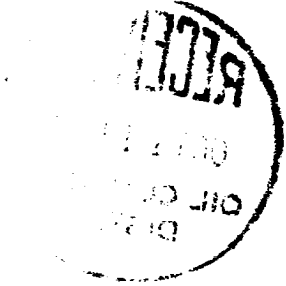
