In March 1997 the Lewis Shale pay was added to the existing Mesaverde interval. A packer and a sliding sleeve in the tubing was placed across the Lewis Shale interval for testing. The packer and sliding sleeve have been removed as follows:

1/12/98

MIRU Big A #40. Closed sliding sleeve and set plug in "F" nipple. ND WH. Installed BPV & NU BOPs. Unseat packer and POOH w/packer and sliding sleeve. Exp check and 1 jt of 2-3/8" tubing (fish) left in hole. Pushed fish to bottom @ 5950'. RIH w/2-3/8" tubing and landed @ 5750' w/"F" nipple @ 5718'. ND BOPs and NU WH. PT tubing. Pump off check. RD & MO. Turned well back over to the production department 1/19/98.
