RIH w/mill and C/O fill to 4790' CIBP. D/O CIBP and chased debris to 2nd CIBP @ 7430'. D/O CIBP. Cleaned out to PBTD @ 7762'. COOH. RIH w/1-1/2" 2.9# tubing and set @ 7666' with "F" nipple set @ 7633'. PT-OK. Pumped off expendable check. RD & released rig 11/20/00.
