On 3-4-70 spudded well, drilled surface hole and ran 7 joints of 5/8", 32-30#, E-40 casing (214') set at 228' w/165 sacks of cement circulated to surface. W.O.C. 12 hours, held 600#/30 Min.

On 3-6-70 T. I. 3586'. Ran 112 joints of 7", 20#, J-55 intermediate casing (3574') set at 3586' w/180 sacks of cement. W.O.C. 18 hours, held 800#/30 Min.

On 3-13-70 M. T. D. 7828'. Ran 247 joints of 4 1/2", 10.5 & 11.6#, J-55 production casing (7816') set at 7828' w/360 sacks of cement. W.O.C. 18 hours.

On 3-14-70 P.E.T.D. 7819'. Perf. 7621-26', 7654-59', 7705-20', 7748-58', 7796-7806' w/15 SPZ. Frac w/60,000# 40/60 sand, 65,000 gal. water, dropped 4 sets of 15 balls, flushed w/5460 gal. water.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
