Load hole w/2% KCL & PT casing & rams to 1500 psi for 30 minutes. Good test. RU & ran GR/CCL/CBL from 5797' - 2700'. TOC @ 3010'. Perf'd Pt. Lookout @ 1 spf .34" holes - 5606'-08', 5590'-92', 5571'-73', 5553'-55', 5538'-40', Total 15 holes. RIH w/pkr & set @ 5341'. Acidized perfs w/1000 gal 15% HCL & ballsealers. Knocked balls off. POOH w/packer. RU to frac. Pumped 60,774 gal slickwater containing 30,400# 20/40 Proppant. RIH w/CIBP on W/L & set @ 5519'. PT - OK. Perf'd Menefee @ 1 spf .36" holes - 15 total. 5497'-99', 5447'-49', 5387'-89', 5322'-24', 5306'-08'. Acidized perfs w/1000 gal 28% HCL & ballsealers. Knocked balls off. POOH w/packer. RU to frac.
