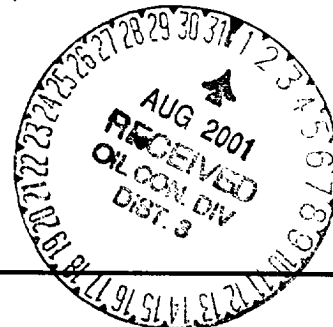

Drilled debris & then cleaned out to PBTD @ 5916'. PU & landed tubing @ 5888' with "F" nipple set @ 5882'. ND BOP, NU WH. PT-OK. Pumped off expendable check. RD & released rig 7/22/01. Turned well over to production to first deliver. This well was put back on line as commingled on 7/26/01 and will be commingled per DHC 137AZ dated 11/1/00.
