We propose to complete the upper Pictured Cliffs formation as follows:

- 1) Pull tubing, run casing scraper to 4,050', set drillable bridge plug at 4,010'; spot 7-1/2% HCl on bottom.
- 2) Perforate following intervals 2 shots per foot: 3882-84; 3902-10; 3914-16; 3946-48; 3956-58; 3980-90.
- 3) Fracture with 70& N2 foam frac with linear gel and 50,000# 20/40 sand (maximum sand 90,000#).
- 4) Clean out and test upper Pictured Cliffs zone.
- 5) Drill out bridge plug. Set tubing at 4,000' and produce.
