MIRU Big A #18. Set plug in "F" nipple. ND WH. Installed BPV & NU BOPs. Unseat packer and COOH w/packer. RIH w/2-3/8" tubing and landed @ 5701' with the "F" nipple set @ 5667'. ND BOPs and NU WH. PT tubing. Pumped off check. RD & MO. Turned well back over to production department.
