Phillips proposes to drill a cathodic protection deep well groundbed. Will drill a 6-7/8" hole to an anticipated minimum depth of 300' (maximum depth of 500'). Cement plugs will not be used unless more than one water zone is encountered. Prior drilling history for the area indicates only one zone to that depth. If more than one water zone is encountered the OCD will be notified and details of cement and casing will be provided.

All drilling activity will remain on existing well pad and "Tierra Dynamic Company" of Farmington will be doing the drilling for Phillips.
