Big A #22 ran 5-1/2", 23#, L-80 liner and set @ 3665'. Top of liner @ 3310'. RU Petro Wireline and ran GR/CCL logs and perf'd w/4 spf (.75" diam) from 3436'-3664'. Total of 368 holes. RD Petro Wireline and ran 2-3/8", 4.7#, J-55 tubing and set @ 3650'. ND BOP's and NU WH. Pressure tested to 3000 psi for 30 minutes - okay. RD and released rig @ 1900 hrs on 3-28-92.
