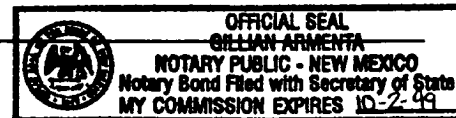

MIRU Big A #18. Set 2-3/8" BPV in tubing hanger. ND WH & NU BOP. PT - OK. COOH w/2-3/8" tubing. RIH & COOH w/liner. RIH w/6-1/4" bit & CO well w/air mist. COOH. RIH w/underreamer. Underreamed 6-1/4" hole to 9-1/2" hole from 3420'-3560'. Used SCT (cavitaiton tool) to cavitate coal intervals. Circulated hole with air & water sweeps, rotating & reciprocated cleaning out to PBTD for @ 5 days. COOH. RU to log. Ran open hole log from 3666' - 3440'. COOH. Surged well w/air & water sweeps.

RIH w/production string and circulated, cleaning out. Landed 2-3/8" 4.7# tubing @ 3650' with "F" nipple set @ 3617'. RD BOPs & NU WH. PT to 3000 psi-15 min. OK. Pulled BPV. RD & released rig 11/2/98. Turned well over to production department.

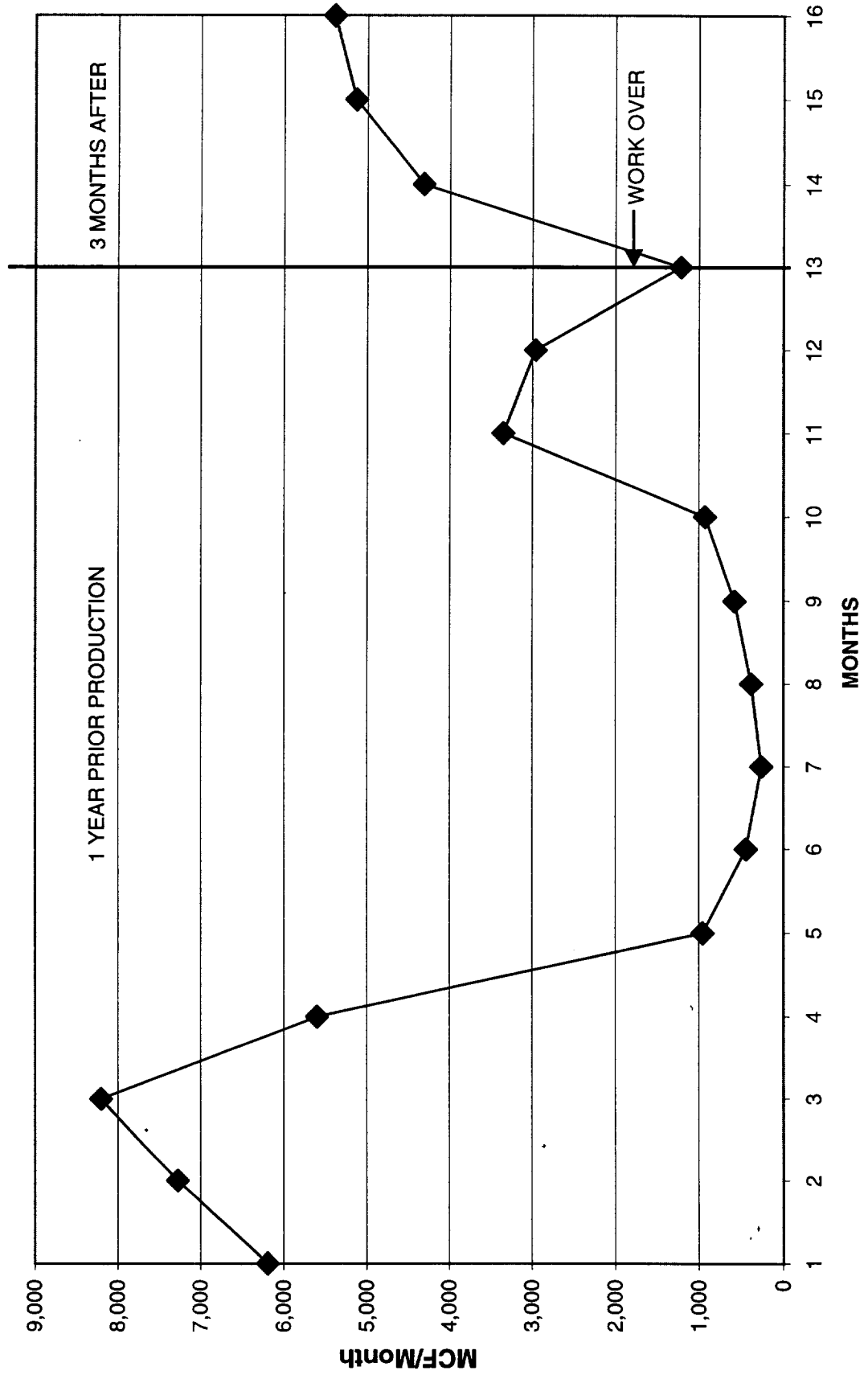
