RIH w/8-3/4" bit & tagged cement @ 310'. Drilled cement & shoe to 350'. Drilled ahead to 3955'. Circ. hole. RIH w/7", 20#, J-55 casing and set @ 3955'. RU BJ to cement. Pumped 10 bbls H2O, 10 bbls mud clean, 10 bbls dye water. Ahead of 520 sx (1237 cf - 220 bbl slurry) Type 3, 35:65 POZ, 6% Bentonite, 0.25#/sx Cello-flake, 5#/sx Gilsonite, 10#/sx CSE, 3% KCL, 0.4% FL-25, 0.02#/sx Static free.

Then tail - 50 sx (70 cf - 12.46 bbls slurry) Type 3, 1% CaCl2, 0.25#/sx Cello-flake. Displaced w/158 bbls H2O. Lost returns at tail end of displacement. Had trace of cement to surface. Plug down @ 13:33 hrs 1/13/00. ND BOP & set slips and cut off casing. NU BOP stake & manifold. PT BOP - 200 psi then 3000 psi. PT casing and rams to 200 psi low and 1500 psi high.
