Tail - 50 sx (70 cf - 12.46 bbls slurry) Type 3, 1% CaCl2, 1/4#/sx Cello-flake. Displaced with 150.7 bbls H2O. Plug down at 2200 hrs 6/20/00. Float held. Circulated 13 bbls (73 cf) cement to surface. ND BOP & set slips and cut off casing. NU BOP & manifold. PT - good test.
