Pumped Tail - 50 sx (70 cf - 12.46 bbl slurry) Type 3, 1% CaCl2, 1/4#/sx Cello-flake. Displaced w/152 bbls H2O. Plug down @ 2030 hrs 8/16/00. 5 bbls (28 cf) good cement circ. to surface. ND BOP, set slips and cut off casing. ND BOP, manifold and lines. PT BOP, manifold and plug to 200 # and then 3000 #. Good test.
