Pumped Tail - 50 sx (70 cf - 12.46 bbl slurry) Type 3, 1% CaCl2, 1/4#/sx Cello-flake. Displaced with 146 bbls H2O. Plug down 1945 hrs 6/2/00. 20 bbls (112 cf) circulated to surface.

ND BOP, set slips and cut off casing. NU BOP & PT - OK. RIH & drilled out shoe. PT casing, rams to 200 psi and 1500 psi. Good test.
