Phillips will be DHC'ing the Mesaverde and Dakota intervals of the subject well per Order # 11363. Production will be reported using the subtraction method for 12 months and then convert to the ratio method for the life of the well. The Dakota forecast for the next 12 months is as follows:

1st month - 5580 mcf	2nd month - 5310 mcf	3rd month - 5395 mcf	4th month - 5134 mcf
5th month - 5216 mcf	6th month - 5129 mcf	7th month - 4881 mcf	8th month - 4959 mcf
9th month - 4719 mcf	10th month - 4795 mcf	11th month - 4715 mcf	12th month - 4188 mcf

The original Reference Case where Partner notification was made was R-10770. Dakota perfs are between 7573' - 7676' with a pore pressure of 2124 psi. The Mesaverde perforations are between 4227' - 5545' with a pore pressure of 550 psi. The value of production will not decrease by commingling. The BLM will receive a copy of this notification also.
