13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recompleate horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. RIH w/8-3/4" bit & tagged cement @ 310'. Drilled cement from 310' to 345'. Drilled ahead to 4150'. Circ. hole. RIH w/7". 20#, J-55 casing and set @ 4150' with ECP set @ 3266' and DV tool @ 3264'. RU to cement. Pumped 10 bbls mud clean, 5 bbls H2O.

Then pumped 1st stage - 225 sx (268 cf - 51.88 bbl slurry) Class H, 0.75% FL-62, 0.2% CD-32, 0.2% Sodium Metasilicate, 5#/sx Gilsonite, 0.25#/sx Cello-flake. Displaced w/40 bbls H2O. & 126 bbls mud. Plug down @ 000709 hrs 12/22/00. Float held. Pressured up to 1500 psi to inflate ECP. Dropped DV tool & opened w/900 #.

Pumped second stage w/10 bbls dye water ahead of Lead - 450 sx (1071 cf- 190.73 bbl slurry) Type 3 35:65 POZ, 6% Bentonite, 0.25#/sx Cello-flake, 5#/sx Gilsonite, 10#/sx CSE, 3% KCl, 0.4% FL-25, 0.02#/sx Static free. Then tail - pumped 50 sx (60 cf - 10.68 bbls slurry) Class H, 0.7% FL-62, 0.2% CD-32, 0.2% sodium metasilicate, 5#/sx Gilsonite, 0.25#/sx Cello-flake. Had 10 bbl good cement circulated to surface. Float held. ND BOP & set slips and cut off casing. NU BOP & choke manifold. PT- OK. RIH w/ bit & drilled out DV tool @ 3263'. Drilled cement shoe to 4140'. PT rams, and casing to 1500 psi for 30 minutes. Good test.
