RIH w/bit & tagged sand @ 5400'. C/O sand to CIBP @ 5450'. D/O CIBP. C/O to PBTD @ 6284'. COOH. RIH w/2-3/8", 4.7# tubing and set @ 5967' w/"F" nipple set @ 5935'. ND BOP, NU WH. PT-OK. Pumped off expendable check and RD & released rig 12/20/01. Turned well back over to production.
