Total 21 holes. Acidized perms w/15 bbls 2% KCl ahead of 26 bbls 15% HCL acid. Frac'd - pumped 69,000 gal 30# XL, 60 Quality foam w/185,000# 20/40 sand. Flowed back on 1/4" and 1/2" chokes. RD flowback equipment. Put well back on line testing Lewis Shale interval flowing up the casing.

Will return within 60 days to D/O CIBPs and run tubing, commingling DK/MV.
