RIH w/8-3/4" bit & tagged cement @ 320'. Drilled cement to 350'. Drilled ahead to 3550'. RIH w/7", 20#. J-55 casing and set @ 3550'. RU to cement. Pumped a preflush 10 bbls water & 10 bbl mud flush & 10 bbls dye water ahead of Lead cement - 460 sx (1109 cf-197.5 bbl slurry) Premium Lite High strength FM. 3#/sx CSE, 3% Potassium Chloride, 0.4% FL-25, 0.25#/sx Cello-flake, 4#/sx Pheno-seal, 5#/sx Gilsonite.

Tail -50 sx (70 cf - 12.46 bbls slurry) Type 3, 1% CaCl₂, 0.25#/sx cello-flake. Displaced w/142 bbls water. Plug down @ 1235 hrs 1/10/01. Circ. 20 bbls cement to surface. ND BOP, set slips and cut off casing. NU BOP & PT BOP, rams and manifold - OK. PT casing to 250 psi low and 1500 psi high - 30 mintues. Good test.
